



ASSISTANCE PARK – Station car park

Assistance park:

All teams will be required to park in the station car park at the discretion of the Organising Committee.

If you wish to reserve a place in the station car park, you must make a written request to the organisation at info@racspa.be. Without a reservation, teams will be placed at the discretion of the organisation.

The request must be sent by 26 May 2023 24:00 at the latest. After this date, the request cannot be taken into account.

The request must include the following elements

- Name of the team
- Contact details of the team manager
- Teams concerned
- Desired layout plan (with dimensions)

Competitors must strictly comply with the plan drawn up by the Organising Committee.

Dimensions :

BRC categories :

Each competitor will have a space of 8 meters in front.

If a "team" assists several cars, it will benefit from an additional space of 5 meters per additional vehicle (i.e.: 13 meters for 2 cars, 18 meters for 3 cars, ...).

Legend Boucles categories :

The maximum authorised space is 50 m² per participating car. Beyond that, and depending on availability, additional m² will be invoiced at $10 \notin / m^2$.

Competitors must strictly comply with the plan drawn up by the Organising Committee.





Security

Electricity

There is no electrical terminal block.

All electrical installations must comply with the General Regulations for Electrical Installations.

The RAC Spa and the City of Bertrix will not be held responsible for any accidents that may occur as a result of an illegal or non-compliant connection and cannot be held responsible for any power cuts.

Fuel

No storage of fuel of any kind will be allowed in the service park and in the service areas, as well as in the service vehicles or/and auxiliary vehicles. The confiscation of fuel will be accompanied by a fine of 500 € served by the race director. The access and circulation of a vehicle carrying fuel in the service park is strictly forbidden.

Only a maximum quantity of 20 litres of fuel necessary to fill the tanks for the equipment (generator, heating, etc) will be tolerated.

<u>Ballast</u>

All temporary structures must be securely fastened or ballasted with a minimum of 5kg per m².

<u>Gas</u>

Gas installations are strongly discouraged. Any gas installations that may be present must comply fully with the legislation in force.

Strict controls will be carried out by the fire brigade. The Organising Committee reserves the right to dismantle any installation that does not scrupulously respect all safety regulations.

Accessibility

Installation can take place from Friday 9.06.2023 at 09:00. Evacuation must be completed by Sunday 11.06.2023 at 20:00 at the latest.

Only one vehicle identified by the sticker "SERVICE" will be allowed in the service park. A vehicle not allowed in the service park will be evacuated.





Miscellaneous

In the service park, it is compulsory to use the bins and containers provided for this purpose by the organisation. It is forbidden to throw away tyres, pieces of glass, brake pads, oil

A fire extinguisher of at least 6kg is compulsory for each competitor's vehicle on each assistance site. It must be visible and its presence may be checked during the event.

Any commercial operation and/or organisation of a reception area is subject to the authorisation of the Organising Committee.

Any damage caused to the service park will be entirely at the expense of the competitor in question.

Access is subject to the covid protocol in force, which will be communicated later.

The use of a ground sheet is compulsory.
